#### FROM THE DESK OF THE SUPERINTENDENT

Included in this issue of the Knight Insight is information regarding both our academic program and our proposed 2017-18 school budget. Regarding our 3-8 State Assessment results, it is a little difficult to interpret the data, as last year almost 30% of our 3-8 students did not sit for the assessment. Because of this, our state assessment results do not accurately reflect student progress in grades 3-8.

Our high school Regents Exam results, however, are still a good indicator of the strength of our high school program. Across the board, our high school students (along with our accelerated 8th graders) demonstrated a much higher level of academic achievement than their peers across the State. This can be seen at both the passing and mastery levels. Additionally, our graduation rate, including the percentage of our students earning an Advanced Regents Diploma, is among the highest in the area.

Regents Exam results and graduation rates are exit outcomes, and as such do confirm a high level of academic achievement for our high school students. When used in conjunction with locally created K-8 assessments, these exit outcomes are also useful in identifying strengths of our academic program and areas where we will seek to improve.

Regarding our proposed 2017-18 school budget, we are continuing the process of aligning staffing levels to best meet student needs. Because of declining enrollment and through attrition, we will experience a slight reduction in staffing levels going into the 2017-18 school year. Also, because of declining enrollment and due to the absence of community based pre-school programs, we will also be reassigning current faculty, so that we may create a pre-k program. In making these changes, we will be enhancing educational offerings for our students, while at the same time keeping personnel costs mostly level from year to year.

We are also continuing the process of addressing deferred equipment needs, which have accrued over the years. Specifically, additional funds have been built into the proposed 2017-18 school budget for the purpose of purchasing musical equipment and classroom furniture.

Finally, the proposed 2017-18 school budget calls for a tax levy increase of 1.20%, which is below our local tax cap. The proposed 2017-18 school budget also reduces the District's reliance on using fund balance (savings) to close the gap between revenues and expenditures.

## **Elementary School Academic Program**

Tully Elementary School offers a comprehensive educational program in grades K-6 to meet the academic, social/emotional and behavioral needs of students. The English Language Arts curriculum contains a combination of programs, including Guided Reading, EngageNY modules, Rebecca Sitton spelling, and Lucy Calkins' Units of Study. Math instruction is aligned with the EngageNY modules. Teachers are implementing the updated New York State Social Studies Standards, which include the new C3 Framework and inquiry-based units. Teachers are also preparing for the rollout of updated New York State Science Standards this Fall. In addition to the core subjects of ELA, math, science and social studies, students also receive instruction in art, computers, library, and music at least once per week and physical education every other school day.

Alignment of our instructional program continues to be a priority at the elementary school. This includes Project-Based Learning (PBL), character education, monthly school-wide meetings, a middle school model at the 5th and 6th grade level, and using the Responsive Classroom framework. Next year, at the elementary school we will also introduce the initial phases of a 1:1 computing device initiative, so that technology may be more easily integrated into the learning process. Our daily Response to Intervention (RTI) time is focused on meeting the academic needs of individual students, and we also offer push-in and pull-out support services for students.

We are in the second year of providing an activity period at the end of the academic day, which students can take advantage of four days each week. In addition to making-up work and receiving academic support, this time is also an opportunity for students to take advantage of a number of clubs and co-curricular activities depending on their grade level. Students can participate in a grade 3/4 Chorus, Jazz Band, NYSSMA, and All-County. We also continue to offer an elementary drama experience for 5th and 6th graders. There is also an intramural program, a Makerspace Club, and Yearbook Club. The Pens, Pencils and More Club gives 6th grade students real-world financial experience by running a school store for students to purchase school supplies. Character Council helps promote school spirit and community service through events like food drives, special clothing days, and the annual March Madness Hoop Shoot.

## Junior/Senior High School Academic Program

At Tully Junior Senior High School we offer a college and career

ready curriculum that provides students with the required courses for graduation and many electives. Students can challenge themselves by taking Advance Placement courses in United States history, biology, statistics and chemistry, as well as honors courses in English and social studies. Our



8th graders have the opportunity to take courses in living environment and algebra for high school credit. Several faculty members teach courses in pre-calculus, business and finance, Spanish, French, and English as part of our partnership with Onondaga Community College. We have articulation agreements with SUNY Morrisville and SUNY Cobleskill for most of our agriculture courses. We also offer elective courses, including Intro to Anatomy and Physiology for students interested in a career in the health professions, Film and Media Studies as an English elective, and Bioethics, which emphasizes scientific research. Extra academic support is provided for students through co-teaching in English and math in grades 7-9, and through Academic Intervention Services (AIS) and special education services. We also offer distance learning courses in American Sign Language through a partnership with OCM BOCES.

At the junior high level, we help students transition from grade 6 to 7 through a series of activities including a "welcome day" in the spring and an orientation in August. Curriculum Night is held early in the school year for all Junior-Senior High School students and parents. A program review of our State Assessment and Regents Exam scores is presented followed by parents meeting with teachers to learn about course syllabi and classroom expectations. Our junior high students have a "flex" period that is tailored by the teachers to meet the needs and interests of individuals and small groups of students, or that can be used for enrichment and interdisciplinary learning experiences.

Tully JSHS offers 31 extra-curricular activities for our students to participate in and has recently added Junior High STAR Club and a Shakespeare Recitation Competition. Last year we officially reinstated Teen Institute and Mock Trial. Students may also compete in 17 Varsity sports along with numerous junior varsity, modified and junior high offerings.

## **BUDGET OVERVIEW & PROPOSITIONS**

**Proposition I:** Shall the Board of Education of the Tully Central School District be authorized to expend the sum of \$19,873,421 as General Fund appropriations for the school year 2017-2018 and levy the necessary tax therefor?

**Proposition II:** Shall the Board of Education lease, finance (1) 66 passenger school bus and (1) 30 passenger bus at an estimated cost not to exceed \$135,000, including necessary furnishings, fixtures and equipment and all other necessary costs incidental thereto and to expend a total sum not to exceed \$135,000, which is estimated to be the total maximum cost thereof, and levy a tax which is hereby voted for the foregoing in the amount of \$135,000, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, issue a lease of the district at one time, or from time to time, in the lease amount not to exceed \$135,000, and levy a tax is hereby voted to pay the interest on such obligations when due?

**Proposition III:** Shall the Board of Education of the Tully Central School District, be authorized to renew the District's 2007 Capital Reserve Fund for a new ten-year term pursuant to Section 3651 of the Education Law and fund such fund in an amount not to exceed \$3,500,000, inclusive of accrued interest and other investment earnings with no annual contribution limit, to be used for renovations and additions to all District facilities, including purchase of equipment, technology upgrades, classroom equipment and/or school infrastructure equipment, site development, athletic fields, storm and sanitary sewer, driveways, and parking lots, such reserve fund to be funded from (i) the balance on deposit in the 2007 Reserve Fund, (ii) year-end budget surplus funds known as unassigned fund balance, as available, for the fiscal year ended June 30, 2017 and each fiscal year thereafter for the term of the reserve fund, (iii) transfers of excess monies from Board of Education designated reserves, (iv) amounts from budgetary appropriations from time to time, and (v) New York State Aid received and made available by the Board of Education from time to time, all as permitted by law?

**Proposition IV:** For the purpose of funding the Tully Free Library, shall the sum of \$181,783 be raised by annual levy of a tax upon the taxable real property within the Tully Central School District?

#### **Board of Education Elections**

In addition to the financial propositions on the ballot, voters will be seclecting two members of the Board of Education, each for a three year term, commencing July 1, 2017 and expiring on June 30, 2020. Nominating petitions were filed by April 17, 2017 (after print time for this issue of the Knight Insight). 

## Frequently Asked Questions

#### Is the "tax cap" really 2%?

Current NYS law does not actually define the local "tax cap" as 2%. Instead, it defines a formula the local school districts must use to determine a local "tax cap". This year our local tax cap is 1.96%. There are actually eight variables in the "tax cap" formula. These variables include the following: the rate of inflation or 2% (whichever is lower), certain local capital expenditures, a portion of the increases in state-mandated pension costs, and a portion of certain legal costs. In some situations, the local "tax cap" can be above 2% and in other situations, the local tax cap can be a negative number.

## What if a school district decides to exceed the "tax cap"?

School budgets that exceed the local "tax levy limit" must be approved by a super majority (more than 60%) of eligible voters. So, if our proposed budget reflected an increase above 1.96%, we would need a supermajority for it to be approved by voters. Since our budget stays within the local "tax levy limit", only a simple majority (more than 50%) of voter approval is required.

## What happens if the budget is not approved by voters?

If a proposed budget is defeated by voters, a school district has a couple of options. The school district could put the same budget up for a re-vote. The school district could decide to put a revised budget up for a vote. Or, a school district could decide to adopt a contingent budget. If a proposed budget is defeated twice by voters, a school district must adopt a contingent budget. If a school adopts a contingent budget some very specific items must be excluded, for example: funding for community use of the schools, certain types of specific salary increases, and new equipment purchases. Additionally, under our current "tax cap" legislation, a school district that adopts a contingent budget may not increase its current tax levy by any amount. This, in effect, translates into a zero percent tax increase.

### **Middle School**

Tully 8th and 9th grade Spanish students had the great fortune to have a guest speaker from Bolivia on Friday, March 17. Sebastian, Rotary

Exchange student this year at Homer High School, traded in his day off to share his South American culture, information about the Rotary Exchange program, and impressions of American life.

We learned a lot about Bolivia and Sebastian. For example, soccer is the most popular sport in Bolivia, with kickboxing a close second. Sebastian eats llama and alligator. The seasons below the



equator are reverse, so it is his summer vacation right now. In Bolivia he attends a small private school, where there are no lockers and there is no study hall. He takes 15 subjects in Bolivia, but is done by 1:00 pm.

It is his city, Santa Cruz de la Sierra, that he misses the most. It is 70 - 100 degrees year round. If it drops to 40 - 50 degrees they cancel school. (Imagine that!) His city, (population +1 million) is referred to as the "City of the Rings" as is evident when viewed from space. Nearby the world's largest Salt Flats are an interesting place to visit. When it rains they say, "Heaven finds earth," as the clouds and blue sky are reflected in the standing water.

### 8th Graders Create Lunch Menus in FLEX Class

8th graders in FLEX class completed a unit that was all about food. They read and discussed multiple excerpts from the book *The Omnivore's* Dilemma by Michael Pollan. They learned facts about the food industry and questioned some of those practices. Students discussed various sources of food that are right here in Tully, and they came to the conclusion that local farms and community gardens are excellent resources for our community's food needs.

They had learned so much, but they wanted something more; they actually wanted to see a change in their everyday lives. They met with our food service manager, Mr. Kennedy, and discussed recipes they wanted to see on their school lunch menu. They were surprised to see the nutritional and financial guidelines that have to be met, and they worked together to create meals that would fit those needs. After some work, they presented their ideas to Mr. Kennedy, and he was able to incorporate them. The lunches served on March 20 – 31 were created by these determined and innovative 8th graders. It was an excellent realworld application, and they were proud to see their lunch ideas being served.

## College & Career Readiness Day

Career representatives from seven major fields came to Tully JSHS to enlighten our students on what their occupations entailed. Eighth and eleventh graders were able to select and listen to these presentations. In addition, tenth and eleventh grades attended a college fair as well. The career sessions and college fair were very informative for all!

## **BOARD OF EDUCATION**

### **Dear District Residents:**

In the spring of 2015 our five year Building Condition Survey (BCS) was completed. In this document, our architects project that we will need to complete \$28 million dollars' worth of repairs to our school campus by 2025. District administrators subsequently worked with members of our Facilities Committee to craft a Long Term Capital Improvement Plan. This plan is based upon using four funding sources: New York State Building Aid, Capital and Repair Reserves, debt retired from previous capital projects, and Smartbond Grant funds. Based upon our current financial projections, we anticipate being able to complete all of the work identified in the 2015 BSC, with minimal impact on the local tax levy.

Our Long Term Capital Improvement Plan calls for larger projects during the summers of 2018, 2021, and 2024. By replacing old debt with new debt, and using funds from our Capital and Repair Reserves, we anticipate that each of these three larger projects will have very little impact on the local tax levy. For example, by using approximately \$950,000 from our current Capital and Repair Reserves, and by timing our 2018 Capital Project to coincide with debt that is being retired, we will be able to fund our upcoming \$12.3 million 2018 project, while increasing local taxes on a \$100,000 home by \$7.39/year.

Our Long Term Facility Plan also calls for smaller projects during the off years, when we do not have larger projects going on. For example, during the summer of 2016 we replaced items that were past their useful lives such as kitchen equipment, our phone system, and our camera and card access systems. In the summer of 2017, we anticipate completing some smaller projects such as an asbestos mitigation project, updating some athletic facilities, and updating our wireless internet network. These smaller projects are typically paid for using Repair Reserve funds or Smartbond Grant funds, which will not add any additional burden to the local tax levy.

The Board of Education has been placing surplus funds into Capital and Repair reserves in order to minimize future borrowing. Given the amount of future repairs identified in our 2015 BCS, the Board of Education anticipates the need for continued funding of our Capital and Repair reserves. Our current Capital Reserve is set to expire at the end of the 2016-17 school year. As a result, there is a proposition on this year's school ballot, asking the Tully community to vote on the establishment of a replacement Capital Reserve. The purpose of this replacement Capital Reserve is to allow the Board of Education to use reserve funds to reduce the school district's need to borrow for future capital projects.

We recognize that our schools are a valuable community resource, and that we have an obligation to maintain them for current and future generations of Tully students. We believe that our Long Term Capital Improvement Plan will allow us to do so in a realistic and responsible manner.
