PROPOSITION #1 - BUDGET ADOPTION

"Shall the Board of Education of the Tully Central School District be authorized to expend the sum of Twenty-Three Million, Five Hundred Eighty-Four Thousand, One Hundred Thirty-Five Dollars (\$23,584,135) as General Fund appropriations for the school year 2024-2025 and levy the necessary tax therefor?"

"Shall the Board of Education lease, finance four (4) 66 passenger school buses at an estimated cost not to exceed \$573,640, including necessary furnishings, fixtures and equipment and all other necessary costs incidental thereto and to expend a total sum not to exceed \$573,640, which is estimated to be the total maximum cost thereof, and levy a tax which is hereby voted for the foregoing in the amount of \$573,640, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, issue a lease of the district at one time, or from time to time, in the lease amount not to exceed \$573,640 and levy a tax is hereby voted to pay the interest on such obligations when due?"
