

**NOTICE OF SPECIAL SCHOOL DISTRICT
MEETING OF THE VOTERS OF THE
TULLY CENTRAL SCHOOL DISTRICT**

THE BOARD OF EDUCATION OF THE Tully Central School District HEREBY GIVES NOTICE that pursuant to a Resolution adopted by the Board of Education of the District on September 16, 2025, a special meeting of the qualified voters of said Tully Central School District in the County of Onondaga, State of New York, will be held in the Tully Elementary School Gymnasium, 20 State Street, Tully, New York 13159 on December 11, 2025 from 7:00 A.M. to 8:00 P.M. prevailing time, for the purpose of voting upon the following proposition:

PROPOSITION

Shall the Board of Education undertake a project consisting of infrastructure upgrades including plumbing, electrical and HVAC improvements, masonry restoration, window replacement, door hardware replacement, lighting/ceiling replacement, various finish upgrades, partial roof replacement, elevator modernizations, UV replacement, classroom renovations and STEM renovations, including site work, original furnishings, fixtures and equipment, architectural fees, and all other costs incidental to such work (the "Project") at a total estimated cost not to exceed \$24,250,000 and obtain the necessary funds by using up to \$2,340,695 from the Capital Reserve Fund approved on May 17, 2022 and, for the balance, the levy of a tax in the amount of \$21,909,305 upon the taxable property of the District to be collected in annual installments in the years and in the amounts as the Board of Education shall determine and in anticipation of such tax bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$21,909,305, and a tax is hereby voted to pay the interest on said obligations when due.

NOTICE IS GIVEN that voting upon the foregoing Proposition will be by paper ballot and will take place on December 11, 2025 in the Tully Elementary School Gymnasium, 20 State Street, Tully, New York 13159 on December 11, 2025 from 7:00 A.M. to 8:00 P.M. prevailing time.

NOTICE IS FURTHER GIVEN that qualified voters may obtain applications for an absentee ballot or early voting ballot from the office of the Clerk of the District. Completed applications for an absentee ballot or early voting ballot must be received by the District Clerk of the District no later than 4:00 P.M. prevailing time, on December 10, 2025 and must be received no later than 4:00 P.M. prevailing time, on December 4, 2025 if the absentee ballot or early voting ballot to be mailed to the voter. Completed applications received after 4:00 P.M. on December 4, 2025, will require the voter to personally appear at the Office of the Clerk of the District to receive an absentee ballot or early voting ballot. A listing of all persons to whom an absentee ballot or early voting ballot is issued will be available for inspection by any qualified voter in the Office of the Clerk of the District between the hours of 8:00 A.M. and 4:00 P.M. during each of the five (5) business days prior to the election.

NOTICE IS FURTHER GIVEN that military ballots may be applied for by qualified voters by requesting an application from the District Clerk at (315) 696-6204 or jeanette.neadom@k12.tullyschools.org. Completed applications for military ballots must be received by the District Clerk no later than 4:00 P.M. on November 14, 2025. In a request for a military ballot application or ballot, the military voter may indicate their preference for receiving the application or ballot by mail, facsimile transmission or electronic mail.
